College Sweepstakes Official Rules**

By entering this Angel City FC Sweepstakes (this “Sweepstakes”), you agree to be bound by these official rules (these “Official Rules”) and all decisions of Angel City FC, LLC (“Angel City” or “Sponsor”) with respect to this Sweepstakes, which will be final and binding:

1. **SWEEPSTAKES PERIOD:** This Sweepstakes will start at 12:01 AM Pacific Time on April 26, 2024 and end at 11:59 PM Pacific Time on May 31, 2024 (the “Sweepstakes Period”).
2. **ELIGIBILITY:** You must not be an employee of Angel City, Sprouts Farmers Market, Inc., Inc. or any of their respective parent companies, affiliates, distributors, subsidiaries, advertising or promotion agencies (a “Related Party Employee”) or an immediate family member (i.e., spouses, parents, children, and siblings and their respective spouses) of, or an individual living in the same household as, a Related Party Employee. All such persons are NOT eligible to enter the Sweepstakes or win a prize. Email addresses must use “.edu” to be eligible.
3. **HOW TO ENTER:** To enter, a person must complete and submit the online sweepstakes form <https://go.angelcity.com/sproutssweepstakes> to receive one (1) entry. Internet access and valid .edu e-mail address are required to enter. Limit one (1) entry per person, regardless of email addresses used, during the Sweepstakes Period. Additional entries received from any person or email



address during the Sweepstakes Period will be void. Entries must be received no later than 11:59 p.m. Pacific Time on the final day of the Sweepstakes Period. Angel City and Sprouts Farmers Market, Inc. are not responsible for any failure to receive an entry due to any reason, including, without limitation, any transmission or technical error of any kind.

4. **SELECTION OF POTENTIAL WINNERS:** On or about June 3, 2024 one (1) winner will be selected by Sponsor in a random drawing from all eligible entries for the Grand Prize, and ten (10) winners will be selected by Sponsor in a random drawing from all eligible entries for the Runner-Up Prize. Each potential winner will be notified by a phone call or email. If a potential winner does not respond within forty-eight (48) hours of Angel City's first attempted notification, or the applicable phone number is out of service and/or the applicable email is returned as undeliverable, an alternate potential winner will be selected in a random drawing from all remaining eligible entries. Each potential winner may be required to provide additional information to verify such potential winner's eligibility (as defined below). Potential winners must execute and return an Affidavit of Eligibility, Liability Release, and where lawful, a Publicity Release within ten (10) days of first attempted notification, failing which the potential winner(s) will be disqualified and another winner selected in the place of the disqualified person in a random drawing from all remaining eligible entries. In the event of a dispute regarding the winner, the person assigned to the email account used to submit the entry (as determined by Sponsor in its sole discretion) will be deemed the winner.
