Season Ticketholder Indication of Interest Sweepstakes Official Rules

By entering this Angel City FC Sweepstakes (this “**Sweepstakes**”), you agree to be bound by these official rules (these “**Official Rules**”) and all decisions of Angel City FC, LLC (“**Angel City**” or “**Sponsor**”) with respect to this Sweepstakes, which will be final and binding:

1. **SWEEPSTAKES PERIOD:** This Sweepstakes will start at 12:01 AM Pacific Time on July 10, 2024 and end at 11:59 PM Pacific Time on August 8, 2024 (the “**Sweepstakes Period**”).
2. **ELIGIBILITY:** You must be eighteen (18) years or older and a legal resident of the fifty (50) United States (excluding legal residents of Florida, New York and Rhode Island) or the District of Columbia, and you must not be an employee of Angel City or any of its parent companies, affiliates, distributors, subsidiaries, advertising or promotion agencies (a “**Related Party Employee**”) or an immediate family member (i.e., spouses, parents, children, and siblings and their respective spouses) of, or an individual living in the same household as, a Related Party Employee. All such persons are NOT eligible to enter the Sweepstakes or win a Prize (as defined below).
3. **HOW TO ENTER:** To enter, a person must either: (i) complete and submit the online entry form at [Premium STMs](#) and [General/Supporter STMs](#) to receive one (1) entry; or (ii) send an email to seasontickets@angelcity.com with entrant’s name, email address, telephone number and mailing address to receive one (1)



entry. Internet access and valid e-mail address are required to enter. Limit one (1) entry per person, regardless of the number of email addresses used, during the Sweepstakes Period. Additional entries received from any person or email address during the Sweepstakes Period will be void. Entries must be received no later than 11:59 p.m. Pacific Time on the final day of the Sweepstakes Period. Angel City is not responsible for any failure to receive an entry due to any reason, including, without limitation, any transmission or technical error of any kind.

4. **SELECTION OF POTENTIAL WINNERS:** On or about August 8, 2024, the twenty-seven (27) winners will be selected by Sponsor in a random drawing from all eligible entries. Each potential winner will be notified by a phone call or email. If a potential winner does not respond within forty-eight (48) hours of Angel City's first attempted notification, or the applicable phone number is out of service and/or the applicable email is returned as undeliverable, an alternate potential winner will be selected in a random drawing from all remaining eligible entries that were received by Angel City prior to the applicable Renewal Deadline (as defined below). Each potential winner may be required to provide additional information to verify such potential winner's eligibility (as described below). Potential winners must execute and return an Affidavit of Eligibility, Liability Release, and where lawful, a Publicity Release within ten (10) days of first attempted notification, failing which the potential winner(s) will be disqualified and another winner selected in the place of the disqualified person in a random drawing from all remaining eligible entries.
